## 7. Fire Fighting Measures

---

- Flammability** : Flammable solid. Runoff to sewer may create fire or explosion hazard.
- Extinguishing media** : Dry chemical, sand, CO<sub>2</sub>, regular foam, water
- Specific Hazards** : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. ## 9. Handling and Storage

---

- Handling** : Keep the product in original packing. Avoid direct sunlight and organic solvents. Keep away from heat, sparks, flame and excessive humidity or moisture. Eating, drinking and smoking should be prohibited in areas where this material is handled, Stored and processed. Use explosion proof electrical equipment.
- Storage** : Store in a dry and well-ventilated area place. Store below 30 °C. It very good if the temperature is below 20 °C. Keep container slightly closed to prevent moisture absorption and contamination.
